COMPOSITION Water based product does not contain any chlorinated solvents in the formulation. CANTESCO® AS SURFACTANT BASED ANTI-SPATTER is not flammable and does not contain any solvent materials, and eliminates concerns regarding hazardous decomposition of chlorinated solvents (resulting in toxic fumes of phosgene gas) that result when heating chlorinated based anti-spatter products.
